We are happy to announce our office is open (and has been for a while) to the public. Tree Sale & Fish Sale

We have been kept very busy this spring with our annual tree sale and fish sale. We are also very grateful that both of these sales and pick ups were able to take place this year as planned!

For the 2021 Tree Sale, we sold a total of 514 packets/items and 15.5 bundles of flags (there are 100 flags per bundle) to 107 individuals.

For the 2021 Fish Sale, we sold 22,923 fish and 7 items to 36 individuals. We enjoyed the beautiful spring weather at pick up!

Thank you for your support in these sales! These are services we are happy to provide to the community and look forward to each year.

New 7 Foot No-Till Drill

The Pickaway SWCD board of supervisors decided it was time to purchase a new no-till drill. The new drill is a Great Plains end wheel 7 foot no-till drill with a standard grain seed box, a native grass seed box, and a fine grass seed box attachment. The drill can be used to plant soybeans, wheat, alfalfa, cool and warm season grasses, and small grains. The rental rate is \$10.00 per acre with a minimum charge of \$100.00. Please visit our website for additional information and to complete the Rental Agreement Form, or contact the office. We hope the drill will be ready for use at our office mid to late April.

Are You Interested in Becoming a Pickaway SWCD Supervisor?

A district supervisor is a local board member, elected from a non-partisan slate of general election, to assess local conservation needs and to develop conservation programs to address these needs. The district is funded by the Ohio Department of Agriculture, the Division of Soil and Water Conservation and the General Assembly, and the County Commissioners.

Supervisors serve three year terms on the board. There is no limit on the number of terms a supervisor can serve, but when their three year term ends they must re-run if they wish to serve another term on the board. Supervisors receive no compensation; they are reimbursed for travel to meetings, registration, meals, and other associated expenses when conducting work of the district.

Primary Duties and Responsibilities

- Attend monthly district meetings (3rd Tuesday of the month, currently meeting at 8:00 or 9:00 am in the morning).
- Participate on district committees and in work groups.
- Be willing to represent the citizens of Pickaway County in regard to conservation issues.
- Be willing to stay informed and inform others about conservation issues.
- Be willing to learn.
- Be willing to participate in statewide meetings and workshops on conservation issues.
- Participate in district policy and program development.
 - a. Prepare strategic and annual plans of work.
 - b. Establish and implement district policies regarding natural resource conservation issues as well as personnel and office matters.
 - c. Develop and/or implement conservation programs (educational and/or technical) to meet the needs of the district.
- Provide financial direction.
 - a. Be responsible for the proper expenditure and management of public funds.
 - b. Review and approve annual budget and financial statement.
 - c. Approve monthly treasurer reports.
- Participate in public and community relations' activities/programs.
- Participate in personnel management.
 - a. Provide guidance and direction to staff and maintain fair and equitable personnel policies.
 - b. Maintain an open working relationship between staff and board members.
 - c. Serve on personnel committee and participate in all aspects of personnel management to include hiring, personnel reviews, etc.

Ohio Native Plant Month



April is Ohio Native Plant Month! Be on the look out for the Green “O” with the Great White Trillium (Ohio’s State Wildflower). This logo represents Native Plant events in Ohio including plant sales, wildflower walks, educational events, planting native plants, or removing invasive plants. Check out our Facebook page throughout the month to see posts on native Ohio plants!

In Ohio, we have over 1000 native trees, shrubs, perennials, vines and grasses that are important to our pollinators, birds, insects, and other wildlife, and humans too! They are part of an intricate, balanced web that helps to filter and clean our drinking water, remove contaminants from the air we breathe, cool our planet, and feed the bees that pollinate most of our food crops. At the very core of this elaborate system are our native plants.

Going native can save money and time over non-native plants, while also providing needed nutrients for butterflies and insects to feed birds. Even better, deep roots of native plants break clay soil to soak up more rain and protect streams by preventing erosion. Non-native invasive plants displace or crowd native plants. Invasive plants impact wildlife, which rely on native plants for food, shelter, and habitat. Not all non-native plants are invasive. About 900 non-native species grow in Ohio and fewer than 100 of them are considered invasive.

Our poster contest for 4th-9th grade students is held in conjunction with Stewardship Week. The theme for this year is “Healthy Forests = Healthy Communities”. All top placing posters will be displayed at the Pickaway County Library and copied into a placemat distributed at Bob Evans during Stewardship Week. Be sure to check them out! Spotted Lantern Fly



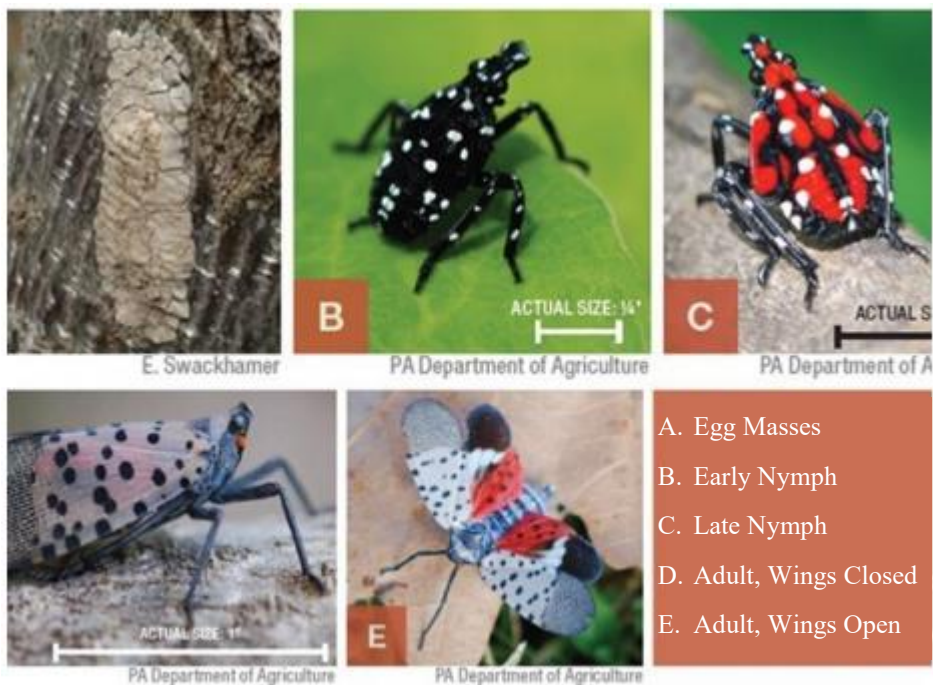
For anyone who watches the news or follows the forestry industry it seems like every week there is a new invasive species that has made its presence known in Ohio. First, we saw Emerald Ash Borer, then Hemlock Woolly Adelgid and Asian Longhorned Beetle. Unfortunately, there is yet another new invasive on the horizon to be aware of. Spotted Lanternfly, native to China, India and Vietnam, was discovered in Jefferson County in late 2020. While not established in Ohio currently, there is the concern of inhabitation.

Spotted lanternfly was first discovered in Pennsylvania in 2014 and has slowly been spreading since that time. This pest, like many others, is a very slow spreader, naturally, but can be spread rapidly by humans, unintentionally. This has led to established populations in Pennsylvania, Delaware, Virginia and New Jersey. This insect is a planthopper that feeds on the sap of many tree species. The biggest concern with these species is that it prefers grapes and fruit trees. This is a multimillion dollar industry across the state. An infestation of Spotted Lanternfly has the potential to be a billion-dollar impact across the range that can support spotted lanternfly, which encompasses the entire eastern half of the United States and portions of the West Coast

The best thing we can do as a community is to keep our eyes open for oddities while we are in the woods. Late summer and into the fall are the best time to spot these insects, as that is when they are adults, and they are most visible with their brightly colored wings. Asking questions about things we see is a great way to learn and also allows us to find and minimize the effects of invasive species.

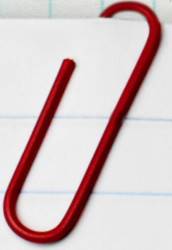

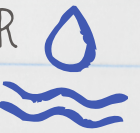

2020 Annual Report

Our Vision and Mission

We are a professional team leading the community in the conservation of our natural resources.

Our mission is to encourage and assist the people of Pickaway County in applying conservation practices, which conserve, preserve, and protect our natural resources for present and future generations.

The Pickaway Soil and Water Conservation District was organized under Ohio law on December 9, 1944. On April 14, 1945, the district was approved by referendum vote of the people and became the 32nd Soil and Water Conservation District in Ohio.

The Pickaway Soil and Water Conservation District, a political subdivision of the State of Ohio, is managed by five supervisors, who are elected by Pickaway County landowners. Supervisors serve without pay and are responsible for developing the local programs, obtaining and disbursing funds, and setting priorities. They also have the authority to hire district staff and to oversee all district activities.

All District programs are offered on a non-discriminatory basis without regard to race, color, national origin, religion, sex, age, disability, political beliefs, marital or familial status, or handicap.

- Co-hosted Pickaway County Virtual Ag Days with Pickaway County Farm Bureau
 - Created videos and activities to share with schools and community featuring Pickaway County Agriculture in the following areas: Dairy Cattle, Hogs, Corn, Bees, Soybeans, and Beef Cattle
- Hosted a 2-day Experience Earth Day Camp for 19 campers in July at the Pickaway County Sportsmen’s Club
- Helped to judge the 4-H Natural Resource Projects for Pickaway County: 15 projects
- Set up a tent with activities at the Pickaway County Fair: approx. 325 people, 26 Cloverbuds for Cloverbud activity

- 4 staff and 5 supervisors attended a total of 45 online and in class trainings, workshops, etc.
- A full audit for 2018 and 2019 was completed in 2020.
